1.0 Background

These conditions can often be treated effectively through conservative measures and patients should be aware of the potential complications associated with these types of surgical procedures which can include pain, stiffness, infection, swelling, non-union recurrence and DVT/PE.

Given this, it is appropriate to ensure that patients are experiencing significant symptoms as a result of their condition, and to ensure that more conservative measures have been attempted prior to considering surgical intervention.

CBA	<p>The ICB will fund surgical foot treatments* where the following criteria are met:</p> <ul style="list-style-type: none"> Where the patient has seen an appropriate MSK clinician and conservative treatment, including change in footwear and lifestyle changes (including weight management advice and support if appropriate), has been evidenced but the patient continues to experience significant functional impairment. <p>AND EITHER</p> <ul style="list-style-type: none"> The patient is suffering from severe deformity over-riding toes which is causing significant functional impairment** <p>OR</p> <ul style="list-style-type: none"> The patient is suffering from severe pain (e.g. Visual Analogue Score (VAS) 7+) that is causing significant functional impairment**. <p>Surgery is NOT funded for concerns about the appearance of feet.</p> <p><i>*Conditions included in this policy:</i></p> <ul style="list-style-type: none"> <input type="checkbox"/> <i>Bunions/Hallux Valgus</i> <input type="checkbox"/> <i>Hallux Rigidus</i> <input type="checkbox"/> <i>Hammer Toe</i> <input type="checkbox"/> <i>Mallet Toe</i> <input type="checkbox"/> <i>Claw Toe</i> <input type="checkbox"/> <i>Pantar Fasciitis</i> <input type="checkbox"/> <i>Morton's Neuroma</i>

Individual cases will be reviewed at the ICB's Individual Funding Request Panel upon receipt of a completed application form from the patient's GP, Consultant or Clinician. Applications cannot be considered from patients personally.
